



Introduction


This database of networks is the collective efforts of GRRIPP awardees from the three [International Seminars](#) which were held in London during 2023.

About GRRIPP

GRRIPP is a 4-year global collaboration and knowledge-exchange project, implemented by seven universities based in Bangladesh, Peru, South Africa and the UK. GRRIPP stands for ‘Gender Responsive Resilience and Intersectionality in Policy and Practice - Networking Plus Partnering for Resilience’ and is funded by UKRI’s Global Challenges Research Fund. GRRIPP was developed in response to the recognition of the humanitarian and development sectors’ need for more gender- and intersectionality-sensitive research, and to transform policy and practice to be more gender- and intersectionality-responsive. In other words, how research can better inform the aid sector about the politics behind gender inequalities that affect people’s everyday experiences, in order to offer more appropriate and contextualised interventions. To achieve this, organisations are required to engage with indigenous and decolonial perspectives on gender and discrimination in crisis contexts, as well as grounding evidence based on the experience from researchers, practitioners, and activists at the grass roots level.

About the Database

As GRRIPP draws to a close, it is important to ensure the longevity of these outcomes. This database is an extension of GRRIPP’s knowledge-exchange, its spotlight and facilitation of initiatives from the Global ‘South’, and its democratisation of access to funding and resources. The database contains an array of useful networks across the globe who provide either funding, resources, aid and services; or a space in which to disseminate research, call for support, or collaborate. The huge amount of knowledge contained within this database has been compiled and mapped by GRRIPPers from across four continents. We hope that sharing this knowledge will springboard existing projects and facilitate the implementation of new ones, signposting resources for those who do not usually benefit from these opportunities.





Methodology

This database was created across three network mapping sessions, which took place during each of the three International Seminar weeks. In February, March and May 2023, GRRIPP UK held a Mapping Networks workshop led by Prof. Maureen Fordham and Dr. Punam Yadav where the aim of this session was to focus on sharing networks and encouraging networking amongst the GRRIPP regions and beyond. After discussing the many varying forms of networks, GRRIPPers were organised into groups according to their regions to discuss the networks that are important to them. Participants were instructed to note any networks that they are a part of or would like to work with and order them into local, regional and international. After a brief discussion, groups were then asked to order their selected networks according to theme, whether that be gender justice, Disaster Risk Reduction (DRR) or healthcare, for example. Once this final task was completed, groups were asked to bring all of their noted networks and to place them onto one large table-length big piece of paper marked as 'Global'. By the end of each session, the piece of paper demonstrated a global exchange and sharing of a multitude of networks covering over 10 themes. This database is the product of this global collaboration of network sharing. In this document, descriptions of the networks have been pulled from their websites and networks are organised by location and theme. Theme headings vary, simply reflecting the known networks in each region.


